¹The Census 2000 average household income is adjusted to 2009 dollars by using the CPI-U-RS adjustment factor published by the Bureau of Labor Statistics (BLS).²Public assistance income includes general assistance and Temporary Assistance to Needy Families (TANF). Separate payments received for hospital or other medical care (vendor payments) are excluded. This does not include Supplemental Security Income (SSI).³Occupied housing units with more than 1.0 occupant per room.⁴Compare with caution - ACS used total occupied housing units and Census 2000 used specified occupied housing units. Specified owner-occupied units exclude mobile homes, houses with a business or medical office, houses on 10 or more acres, and housing units in multiunit buildings. Specified renter-occupied units exclude 1-family houses on ten or more acres.⁵2005-2009 American Community Survey data is a 5-year average file. It is the most recent data set available in 2000 Census boundaries.⁶Margins of error (MOE) for the 2005-2009 ACS data are based on a 90% confidence level.
